# 32<sup>nd</sup> meeting of the High-level Group for Partnership, Coordination and Capacity-Building for the 2030 Agenda (HLG-PCCB)

Virtual meeting 11 September 2023, Open meeting

#### Opening

1. Ms. Dhuli and Mr. Annim (co-chairs) together with Mr. Schweinfest (Director of the Secretariat) welcomed members and issue partners to the meeting.

#### Cape Town Global Action Plan (CTGAP): updates

- 1. The secretariat shared a paper prior to the meeting with a proposed timetable for the second phase of the CTGAP revision process together with a summary of the first phase outcome and other background information. Following the request at the last meeting to reform a subgroup to work on the second phase, the membership now consists of: Albania, Ghana, Colombia, Pakistan, Poland, Spain, Switzerland, and Uruguay with issue partners GPSDD, Paris21, UNESCAP and UK FCDO. The next step would be to convene a meeting of the subgroup to decide on the parameters and methods to carry out the revision, and thereby prepare for an in-person meeting of the group to develop these ideas further. the revision in time for its launch at the.
- 2. Members mentioned where the topic of data was being discussed in high-level settings such as the G20 declaration, the <u>Data Dividend High Impact Initiative (HII)/ 2030 Data Action Plan</u> at the UN SDG Summit 2023 and the UN Summit of the Future 2024. It was suggested to create an inventory of these references.
- 3. The secretariat updated the group on plans for a <u>survey on the implementation of the CTGAP</u> conducted by the secretariat with partners, PARIS21 and the World Bank. The current proposal is to plan to launch a third round of the questionnaire in late 2024. The survey could help to establish a baseline just after the CTGAP revision is launched at the fifth UN World Data Forum.

## Preparatory work for the UN World Data Forum (UNWDF)

4. Ms. Urdinola and Mr. Mendez (Colombia) gave the group a brief update on the preparations for the UNWDF in Medellín, Colombia and offered more details at the group's next meeting. The secretariat provided an update on the status of the Programme Committee where 24 of the 26 persons invited had accepted the invitation to serve on the Committee with the first meeting scheduled for Thursday, 21 September.

Follow-up on the two outstanding responses would continue; but getting a member from the media to serve on the Committee had proved challenging in the past so any additional nominations from the group was welcome.

5. Ms. Awad and Ms. Badiee were introduced as the continuing co-chairs of the Programme Committee to maintain much needed continuity as the next Forum will likely take place in less than 15 months. The co-chairs mentioned a range of issues identified from the last Forum, they would discuss during the business of the Committee including measuring the impact of the Forum, improving links to other communities (i.e. digital agenda, financing, etc.) and participant representation (i.e. youth, private sector), continuation of the thematic areas, building back the in-person nature of the Forum, localization through different types of meet-ups, greater multilingualism, and more inter-Forum promotion and events.

### Updates on global initiatives related to the financing of data and statistics

6. The secretariat and issue partners from the GPSDD, PARIS21 and the World Bank gave the latest updates on the respective initiatives. GPSDD reported on the <u>Data Dividend High Impact Initiative</u> (HII), one of twelve initiatives being promoted at the UN SDG Summit being held during the UN General Assembly High-level Week 2023. The Data Dividend HII aims to mobilise high-level political guidance on the data leadership and investment needed to support the transformative and accelerated actions in the lead up to 2030. High-level political leaders, goodwill ambassadors, UN senior officials, civil society and private sector leaders will hold an <u>event on the 17 September to be broadcast on UNTV</u>. PARIS21 reported on the latest monitoring of statistical funding and latest figures showed a recovery to pre-Covid levels, but better financial support to data and statistics remained a priority. Finally, World Bank reported good progress on the implementation of the Global Data Facility and offered to present more details at a future meeting.

### Working arrangements updates

7. Members were sent a poll to understand their availability for an in-person meeting either in the week of beginning 11 December 2023 or later in April 2024 with dates to be determined. Ms. Dhuli generously offered the facilities and help of her office to host this meeting. If at least half of the members were not available in December, then the next meeting of the group would be at the side lines of the 55<sup>th</sup> UN Statistical Commission to take place on Sunday, 25 February 2024.
