# 35<sup>th</sup> meeting of the High-level Group for Partnership, Coordination and Capacity-Building for the 2030 Agenda (HLG-PCCB)

Virtual meeting 3 September 2024, Open meeting

#### Opening

1. Ms. Dhuli and Mr. Annim (co-chairs) together with Mr. Schweinfest (Director of the Secretariat) welcomed members and issue partners to the meeting.

#### Workplan review (January – December 2024)

- a. Selection of sixth UN World Data Forum (UNWDF) host
- 2. The secretariat informed the group regarding the special meeting to be held on Thursday to hear presentations from the bidding countries and vote on the sixth host. Members are required to register no more than two persons per member country and identify the designate/alternate voter. A vote will be conducted until a majority present and eligible select one bidder.

Action: Members requested to complete the <u>REGISTRATION FORM (RVSP)</u> by TODAY to attend the special meeting this Thursday to select the sixth host of the UNWDF as the meeting link will only be shared with these registered participants.

# b. Programme of the fifth UN World Data Forum (UNWDF)

- 3. Mr. Mendez (UNWDF host country, Colombia) mentioned preparations for the fifth UNWDF in Medellín, Colombia was well underway with countless preparatory meetings undertaken to agree plans and mobilize the data and statistical ecosystem in Colombia. The <u>registration</u> to attend was now open until 30 September and he looked forward to welcoming all participants to the conference venue in November.
- 4. Ms. Badiee and Ms. Awad (co-chairs of the Programme Committee) confirmed the <a href="programme">programme</a> was released last month. The current programme reflects the comments received at the last meeting where there are now more lead organisers from a National Statistical Office featured on the programme.

#### c. Consultation on CTGAP 2.0 and other outcomes of the fifth UNWDF

5. The secretariat with partners (ODW/Paris21) and the host country of the Forum (Colombia) presented the status of CTGAP 2.0, the working title for the work on the realignment of the Cape Town Global Action Plan (see accompanying slides). The secretariat provided details on what had changed in the documents since the last meeting and described plans for a public consultation. The host country shared the work ongoing to engage national stakeholders on the outcomes. The partners leading the work on the Commit to Data campaign outlined the progress since its launch and how it would be developed up to and beyond the Forum.

Action: HLG members and issue partners to review and provide comments to the secretariat by Friday, 13 September 2024 on the two documents: CTGAP 2.0 document containing the priority framework (in MS Word) and the action framework (in MS Excel).

#### Reporting from issue partners on work related to HLG-PCCB agenda

6. Issue partners from GPSDD, PARIS21 and World Bank gave their updates on their increasing connected work with the <a href="Power of Data">Power of Data</a> looking ahead to the fourth International Conference on Financing for Development (FfD4) conference to be held in Spain next June/July; the replenishment of the World Bank's International Development Association (IDA) funds; and an appeal to build the narratives for better funding for data and statistics using existing platforms and tools (i.e. Clearinghouse for financing development data).

## Review of the Terms of Reference (ToR)

7. The secretariat would have an opportunity to review and update their ToR at the next inperson meeting at the fifth Forum. Any agreed changes would be submitted through the group's report to the Statistical Commission in late November.

Action: HLG members to review the existing <u>Terms of Reference (ToR)</u> and provide comments and suggestions on how the ToR can be improved to strengthen participation and engagement among members (including the scope of work). This will be a key item for discussion at the 36<sup>th</sup> meeting to be held in Medellin at the sidelines of the fifth UN World Data Forum.

### Any other business

8. Mr. Rothen (Switzerland) introduced a proposal to conduct an independent evaluation of the UN World Data Forum as it reached its fifth edition. Mr. Schweinfest mentioned two issues were the funding for this exercise and the choice of evaluator. Several issue partners (GPSDD, Paris21 and ODW) offered their support in this process.

Action: The Secretariat is looking at potential next steps and inform the HLG-PCCB what is feasible and how the group will handle the evaluation at the next meeting.

9. Next meeting will take place before and after the sixth UN World Data Forum: Tuesday, 12<sup>th</sup> and Saturday, 16<sup>th</sup> November 2024 (both in the morning).
