### Has work for the development of this indicator begun?

Yes, work is proceeding well.

1) Thanks to the ongoing project on the 2017 Global SPP Review, National Focal Points in charge of SPP policies have been identified in 55 countries. A survey has been designed and shared with the national focal points to assess the progress of SPP policies among member States. As a result, 40 national SPP fact sheets have been drafted and are being used to develop the 12.7.1. indicator measurement process.

# What is the involvement of or how do you plan to involve National Statistical Systems in the development of the methodology?

This is a policy-related indicator, therefore we assume that at the national level information will be collected from relevant line ministries, however, as part of the methodological development we shall consult with National Statistical Offices both on the methodological approach and on the data collection plan.

## Please briefly describe the process of developing the methodology for the indicator

The work is undertaken by the Sustainable Public Procurement Team of UN Environment in consultation with the Sustainable Public Procurement Programme of the One PlanetNetwork (10 Year Framework of Programme on Sustainable Consumption and Production).

UN Environment has developed a proposal for a composite index made up of measurable sub-indicators. This has been shared with the One Planet Multistakeholder Advisory Committee members for consultation. These sub-indicators are derived from the results of the Global review survey and questionnaire as well as through further interaction with SPP stakeholders and policy makers in countries where SPP policies and action plans are being implemented (see proposal in annex).

- Development of the draft methodology: July-October 2018
- Approval of the SDG 12.7.1 methodology by the Multistakeholder Advisory Committee of the One Planet Network SPP Programme: November 2018
- Testing of the methodology: November-December 2018
- Revision of the methodology based on lessons learned from the testing phase: January 2018
- Submission to Inter-Agency Advisory Group (SDG): February 2019
- Data collection through survey: 2019
