1. Coverage of data

Notes for Section 1 Coverage of Data:

- For all population group covered in section 1, they will be included in the population estimates if they self identified in census that they usually live in New Zealand. The population estimates then include an adjustment for net census undercount and residents temporarily overseas at census date.
- For (d), they will be counted in census and subsequent estimates if they are in New Zealand territorial water (within 12 miles of land) or on a passage between New Zealand ports.
- Population estimates are updated for permanent and long-term migration, which is based on the length of stay in/absence from New Zealand of 12 months or more. Classification of each passenger is primarily determined by the passenger's response, on the arrival/departure card, to the question on intended or actual length of stay/absence. If the person's intention changes later during the trip, then they may also change their migration category.

2.2 Population by age and sex
