UN Comtrade Data Availability, Data Revision and Usage

UNSD Report

I. Data Availability

1. UN Comtrade contains 45 years of detailed annual trade data for over 170 countries (or areas). As of 14 October 2009, there were 134 countries for the most recent reporting year 2008 available on UN Comtrade which is eight less than at the end of 2008, but is more than released in any other year except 2008. Overall, data availability in terms of number of countries and timeliness on UN Comtrade has been significantly improved in previous years (see Table 1).



2. The maximum number of reporters per reporting year is 175 for 2004 (four years after the first year of data release in 2005). This number can be considered as a benchmark for the maximum number of countries per reporting year. Even though only 134 countries have reported data for the most recent reporting year 2008, this data accounts for around 90 percent of World Trade.

Annex 1 shows the availability of data on UN Comtrade for the reporting years 1998 to 2008 by country and commodity classification.

3. Graph 1 below shows the increase of available country periods in UN Comtrade since the beginning of 2006 up to October 2009. On average, UN Comtrade added 16 new country periods per month and 178 new country periods per year.

II. Data Revision

4. UNSD receives new data and revised data for the latest and previous reporting years. So far during 2009 countries submitted 269 new and revised country periods (datasets) for the four reporting years 2005-2008. Of those, 100 (37.17 percent) were revised country periods. The number of revised datasets increased significantly in the previous years (see Table 2 for details). The publication of revised data accounts for a significant portion of UN Comtrade operations.



5. So far during 2009 a total of 29 countries provided 32 revised datasets for the latest/current reporting year 2008. One of these 29 countries provided 4 revised datasets – meaning all other countries provided one revised dataset.

III. Usage

6. In our last report on UN Comtrade usage statistics for the previous EG-IMTS meeting in December 2007 the number of users per month were about 10,000 and the number of queries were around 250,000 per month. Most of these users are guest users which use the database for free. As can be seen in Graph 2 below, the number of users increased to around 15,000 per month and the number of queries increased to 300,000 per month.

7. Since the beginning of 2008 UN Comtrade data has been made available within UNdata (<http://data.un.org>). UNdata is the United Nations Data Access System which gives access to current, relevant and reliable statistics for free (users can download up to 50,000 records per query). UNdata contains around 15.7 million trade records on 6-digits level of HS 1992 classification from the year 1998 up to the most recent year.
8. In addition of UNdata, UN Comtrade data are also re-disseminated by other international organizations such as World Bank (WITS-World Integrated Trade System), International Trade Center (Trade Map / Market Access Map), OECD, ESCWA, ECLAC and some other research institutions or private companies.
