#### 1. Current recommendation(s)

(IMTS, Rev.2, para 160) **Index numbers.** Although price indices are generally preferred, in practice, countries may not have the resources available to compile that information. It is recommended that all countries produce and publish volume (quantum) indices and either unit value or price indices for their total imports and exports on a monthly, quarterly and annual basis. Countries are also encouraged to calculate and publish such indices for the detailed commodity groups at least quarterly.

#### 4. UNSD observation of wwc result

There is **overwhelming support** (83%, with no-answers 8%) for the proposal to provide more detailed recommendations on the compilation, dissemination and use of external trade indices. **Almost 60% of countries calculate and use unit values for the compilation of external price indices while about 30% of countries use price surveys for this purpose. Comments suggest to indicate the pros and cons of both, price surveys and unit values when compiling external trade indices and to give details in the Compilers Manual. Some countries suggest making reference to the forthcoming IMF publication on this issue.** 

Only about **20% of developing and transitional countries** conduct and use price surveys (21 and 18 respectively). **56% of developed countries** conduct price surveys but only 41% use it for the compilation of external price indices. Surprisingly, 79% of developed countries calculate unit value indices and 76% use them for the compilation of external trade indices. These percentages are 50% and 46%, respectively for developing/transitional countries.

# Compilation of seasonally adjusted data

#### 1. Current recommendation(s)

(IMTS, Rev.2, para 161) **Seasonally adjusted data**. The publication of seasonally adjusted monthly/quarterly data, including both values and index numbers, provides additional valuable information required for economic analysis. Countries are <u>encouraged</u> to publish such data on a regular basis.

# Compilation of seasonally adjusted data

#### 4. UNSD observation of wwc result

A clear majority of countries (62% with no-answers 15%) support to explicitly recommend the dissemination of seasonally adjusted data. There is good support (55%) for recommending one particular adjustment method but also significant opposition (21%). Comments suggest leaving it to countries or analysts to decide on the appropriate seasonal adjustment methods as national circumstances vary. Also using the same tool might no lead automatically to comparability.

Many developed countries (41%) reject the second part of this proposal and 29% reject part 1. Developed and transitional countries support both parts of the proposal strongly – 66% and 63% respectively, with no-answers 9 and 12%, respectively).

# Issues raised (open list) - continued

- The EG requested to delineate more clearly the differences between international merchandise trade statistics and national accounts or balance of payments statistics and provide clear guidelines on how to derive the latter.
  - → See chapter 5 in the Supplement to the Compilers Manual
- □ The EG requested that linkages to and possible integration with other statistical domains be explored.

#### Reconciliation between IMTS and General Merchandise on a BOP Basis

Merchandise trade statistics as provided in data source Adjustments, as relevant - for example: - CIF/FOB adjustment - Goods for processing without change of ownership - Goods imported for projects by nonresident construction enterprises - Returned goods - Migrants' effects - Inventories of goods held abroad (at time of dispatching abroad) - Computer software and audiovisual products (non-customized with periodic license for use) - Goods lost or destroyed before change of ownership + Goods lost or destroyed after change of ownership + Goods entering/leaving territory illegally + Goods procured or supplied in ports by carriers + Inventories of goods held abroad (at time of sale) + Fish catch, minerals from the seabed and salvage sold from resident-operated vessels in foreign ports or from resident-operated vessels on the high seas to foreign vessels + Equipment that changes ownership while outside the territory of owner
