Mandate of the Statistical Office

- > Ghana Statistical Service (GSS) was established by law in 1985.
- > Before then, was known as Central Bureau of Statistics, a department under the Ministry of Finance and Economic Planning
- SSS mandated as sole government agency to conduct censuses and surveys to collect, compile, analyze and publish statistics in the country
- Also to compile data from administrative records and assemble them for publication
- > Also coordinate all statistics activities in the country
- Advices government on all issues relating to statistics

GSS accomplishes this through Divisions and Sections

- > Industrial and Trade Statistics Division
- > Trade Statistics Section

Data sources and format for declarations

- > The main source of data is the customs declarations
- > Declarations are obtained in both electronic format and paper declarations; electronic format from ASYCUDA and paper for overland entry/exit points
- ASYCUDA replaced by Ghana Community Network (GCNet) with the airport connected in December 2002 and the seaports in July 2003.
- Institutions depending on customs data have been linked to the GCNet to make it possible to download data online. This is done through a software known as Cognos Impromptu
- Declarations by agents are also now possible online using a front-end software (FES)

Type of trade system

- > Ghana has been using the General Trade System since 2000. This was based on the recommendations in the UN Manual on Merchandise Trade
- > Before then, the Special Trade System was in use
- Movement of goods between warehouses and between free zones are not published

Checks on data from customs

- * The declarations are first loaded into a spreadsheet to ensure that all the required fields have been provided
- * Any errors that can easily be corrected are effected before data transfer
- In the case of blank fields this is brought to the attention of customs for correction
- * The blanks mostly encountered are those for the supplementary unit

Other data sources are:

- > Data from the import/export of electrical energy from the Volta River Authority
- > Data on crude oil imports from the oil refinery
- Export data on non-traditional commodities and overland exports from the Ministry of Trade and Industry
- Introduction of the Ghana Community Network (GCNet) makes it possible for electronic submission of declarations

Time schedule for data processing

- Data obtained from CEPS under ASYCUDA with a time lag of about three months. Data processed immediately after receiving from customs
- ❖ Data extraction from the different ports by a team from the headquarters caused the delays
- * Institutions connected to GCNet can download data online, but there are a few data problems that a committee has been set up to resolve.

Discussion with other agencies before publication

- * There are no formal discussions with other agencies before publication
- The declarations, as captured by customs is difficult to verify from other sources
- * The central bank holds consultations with the Statistical Office and Ministry of Trade when data delays and the bank has to prepare estimates for the balance of payments
- * A national committee on trade statistics is to review current methodologies for compilation and make recommendations for a common approach
